The Initial idea of Members Database dates from IFLA Europe General Assembly in Oslo, Norway in 2014. IFLA Europe Executive Council, with full support of the General Assembly, agreed the need for a more cohesive IFLA Europe that is able to provide its National Associations and their members opportunities to develop their capacities at European level.

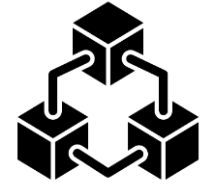

STRUCTURE

Members' Database is split in three parts:

The first part consists of general questions of personal communication data, membership, educational qualifications and professional status.

The second part is about the areas of knowledge and expertise, as well as networking activities in European, International Organisations and participation in working group activities of IFLA EUROPE.

In the third part, members are asked to respond to Professional Mobility issues, which do not allow them to practice landscape architecture profession in another country.
